## (REPOST) CATECHESIS: SATURDAY EVENING MASSES

MOST PEOPLE AREN'T OLD ENOUGH TO REMEMBER, BUT SATURDAY EVENING MASSES ARE A RATHER NEW THING. IT STARTED IN THE 1920'S SO THAT THOSE WHO WERE SERVED BY PRIEST-CHAPLAINS COULD ASSIST AT MASS WITHIN THE CONFINES OF THE DAILY SCHEDULE OF A HOSPITAL OR PRISON, ETC. THIS ALLOWANCE FOR HOLY MASS TO BE CELEBRATED IN THE EVENING WAS EXTENDED FURTHER DURING WORLD WAR TWO. IN THE 1950S, VENERABLE POPE PIUS XII ALLOWED THE EVENING CELEBRATION OF HOLY MASS TO BE EXTENDED WIDELY TO PARISH CHURCHES. WHEN CELEBRATED ON A SATURDAY EVENING, THIS MASS WOULD SATISFY ONE'S SUNDAY MASS OBLIGATION.

HOWEVER, IT WAS (AND STILL IS) TO BE CONSIDERED AN EXCEPTION. SUNDAY IS THE DAY TO FULFILL ONE'S OBLIGATION TO GO TO HOLY MASS. SATURDAY FULFILLMENT OF THE OBLIGATION WAS AN ALLOWANCE FOR THOSE WHO COULD NOT REASONABLY ATTEND MASS ON SUNDAY. IF IT WAS (AND IS) REASONABLY POSSIBLE TO GO TO HOLY MASS ON SUNDAY, THAT IS WHEN ONE SHOULD GO TO MASS. THE SATURDAY EVENING MASS WAS NOT "INVENTED" SO ONE COULD SLEEP IN ON SUNDAY, OR GET AN EARLY MORNING TEE-TIME AT THE GOLF COURSE. IT WAS INITIATED SO THAT THOSE, FOR EXAMPLE, WHO HAD TO WORK OR TRAVEL ON SUNDAY COULD STILL WORSHIP GOD AT THE HOLY SACRIFICE OF THE MASS, FULFILLING THE OBLIGATION.

MORE ON THIS TO COME AS WE PREPARE FOR THE WINTER MASS SCHEDULE AND THE EVENTUAL ADDITION OF ST. JOHN CANTIUS PARISH TO OUR LAKE COUNTY CLUSTER OF CHURCHES.

DURING THE SATURDAY WINTER MASS SEASON (NOVEMBER'24 TO APRIL'25), A VERY CLOSE MASS ATTENDANCE COUNT WAS TAKEN.
